Submission Deadline	All claims must be submitted online and back up material must be received with in 30 days of online submission. All claims that do not have all of the required backup information by this time will be rejected.
Claims/Disputes	Disputes for rejected claims must be submitted within 60 days of date of claim rejection. Each end user will be limited to one resubmission. To dispute a claim, end user should log on to submission website and email or call customer service at the email address or toll free phone number provided. In the event of any questions or interpretation of the terms and conditions listed in this promotion, the decision of Sony will be final.
To Redeem Points	<ul style="list-style-type: none"> • End user must log onto www.sony.com/extracredit to redeem their points for eligible Sony Broadcast and Professional products via the online catalog. • The end user can only spend what they have earned in Extra Credit Points.
